SECOND READING ORDINANCES

1. Council Bill/Special Ordinance 4039-2014

2. Council Bill/Resolution 1121-2014

A Resolution authorizing approval of a Request from the Moline Rotary Club to create the Moline Rotary Plaza on City-Owned Property.

EXPLANATION: The Moline Rotary Club proposes to create a landscaped plaza in the greenspace north of the Moline Police Station where the City Hall Annex Building formerly stood. The estimated cost of the work is \$40,000 and will be performed at no cost to the City. The City will assume maintenance responsibilities after the installation is complete.

3. Council Bill/Resolution 1122-2014

A Resolution declaring the following Article 36 seized and forfeited vehicle as surplus property: 2006 Ford Econoline van, VIN# 1FTNE24W86HB44682.

EXPLANATION: Illinois State Statute provides that law enforcement agencies may seize vehicles used during the attempt or commission of specific crimes and subsequently initiate forfeiture proceedings on those vehicles. The above vehicle has been forfeited to the police department, and staff is requesting that it be declared as surplus property and disposed of by the Finance Director through the legal disposal process that is most advantageous to the City, whether sealed bid, auction, negotiation, or otherwise.

FISCAL IMPACT: Any proceeds after costs are for use by the seizing law enforcement agency.
