**Council Meeting:** The City Council meeting came to order at 6:50 p.m. The Council met in regular session in the Council Chambers at City Hall.

**Pledge:** The Council and audience recited the Pledge of Allegiance.

**Invocation:** Alderman Acri gave an Invocation.

**Roll Call:** Roll call was taken with Mayor Raes, Aldermen Rodriguez, Parker, Wendt, Zelnio, Turner, Liddell and Acri present. Absent: Alderman Schoonmaker

### **Second Reading Ordinances**

#### **1. Council Bill/General Ordinance 3040-2015**

An Ordinance amending Chapter 8, "BUILDINGS AND OTHER CONTRUCTION AND BUILDING SERVICES," of the Moline Code of Ordinances, Section 8-1401, "ELECTRICAL CONTRACTOR LICENSE," by repealing said section in its entirety and enacting in lieu thereof one new Section 8-1401, entitled "ELECTRICAL CONTRACTOR LICENSE AND REGISTRATION," dealing with the same subject matter; and by amending Section 8-1402, "MECHANICAL CONTRACTOR LICENSE," by repealing subsection (b) in its entirety and enacting in lieu thereof one new subsection (b) dealing with the same subject matter; and by amending Section 8-6101 "AMENDMENTS TO MOLINE ELECTRICAL CODE – GENERAL," by repealing subsection (e) in its entirety and enacting in lieu thereof one new subsection (e) dealing with the same subject matter.

**A Resolution Authorizing the Mayor to sign a letter of support for submission with Gorman & Company's application to the Illinois Housing Development Authority for funds to redevelop the former Garfield Elementary School at 1518 25<sup>th</sup> Avenue, Moline, Illinois.**

**9. Council Bill/Resolution 1033-2015**

**A Resolution authorizing the Mayor and City Clerk to execute an Eleventh Addendum to a Letter of Agreement between the City of Moline and Lewis J. Steinbrecher.**

**10. Council Bill/General Ordinance 3043-2015**

**Adopted:** Alderman Parker, seconded by Alderman Turner, moved to adopt Council Bill 3043-2015. Motion carried on roll call with the following vote: ayes: Aldermen Rodriguez, Parker, Wendt, Zelnio, Turner and Liddell; nays: Alderman Acri

**11. Council Bill/General Ordinance 3044-2015**

**An Ordinance amending Chapter 20, "MOTOR VEHICLES AND TRAFFIC," of the Moline Code of Ordinances, Appendix 10 thereof, "PARKING PROHIBITED AT ANY TIME," by including 25<sup>th</sup> Avenue A, on the north side, from 29<sup>th</sup> Street west to the dead end.**

**12. Council Bill/General Ordinance 3045-2015**

**An Ordinance amending Chapter 20, "MOTOR VEHICLES AND TRAFFIC," of the Moline Code of Ordinances, Section 20-5124, "UNAUTHORIZED PERSONS USING PERSONS WITH DISABILITIES PARKING SPACES; A VIOLATION," Appendix 24, "PERSONS WITH DISABILITIES PARKING SPACES," by including one on-street stall at 155 4<sup>th</sup> Avenue.**

**13. Council Bill/General Ordinance 3046-2015**

**An Ordinance amending Chapter 20, "MOTOR VEHICLES AND TRAFFIC," of the Moline Code of Ordinances, Appendix 11 thereof, "PARKING PROHIBITED AT CERTAIN TIMES," by including 48<sup>th</sup> Street, east side, from 44<sup>th</sup> Avenue to 46<sup>th</sup> Avenue, for the hours of 7:30 a.m. to 8:30 a.m. and 1:00 p.m. to 3:30 p.m. on school days.**

**Council, Staff and Citizen Comments:**

Alderman Rodriguez expressed appreciation to the Fire Department and for its involvement in the field trip for the Washington Elementary School special needs student as well as the media coverage from *The Dispatch*. Additionally, Alderman Rodriguez thanked the Planning & Development Department for the Open House held on Thursday, November 5, 2015, at Stoney Creek. Lastly, Alderman Rodriguez thanked veterans for their service.

Mayor Raes thanked the Moline Public Library for the Veterans Day program.

Alderman Turner expressed appreciation to the Keystone Associations Hildago Neighborhood group for the fundraising efforts for McCandless Park. \$12,000 has been raised for the pavilion.
