AN ORDINANCE

AMENDING

Chapter 15, "GARBAGE AND TRASH," of the Moline Code of Ordinances, Section 15-2102, "CURBSIDE RECYCLING CARTS," by repealing subsection (b) in its entirety and enacting in lieu thereof one new subsection (b), dealing with the same subject matter; and amending Section 15-2200, "FEE FOR RESIDENTIAL REFUSE COLLECTION," by repealing said section in its entirety and enacting in lieu thereof one new Section 15-2200, dealing with the same subject matter.

WHEREAS, the City of Moline ("City") is a home rule municipal corporation organized and operating in accordance with the Constitution and laws of the State of Illinois; and

WHEREAS, Chapter 15 of the Moline Code of Ordinances contains the City's sanitation policies and procedures; and

WHEREAS, the Director of Utilities and the Director of Finance have reviewed Chapter 15 and have recommended changes related to the fee structure effective upon the first billing after January 1, 2024; and

WHEREAS, at the September 19, 2023, roundtable meeting, the City Council approved the new fee structure.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF MOLINE, ILLINOIS, as follows:

<u>Section 1.</u> The foregoing recitals are hereby incorporated into this Ordinance as though fully set forth in this Section 1.

Section 2. That Chapter 15, "GARBAGE AND TRASH," of the Moline Code of Ordinances, Section 15-2102, "CURBSIDE RECYCLING CARTS," is hereby amended by repealing subsection (b) in its entirety and enacting in lieu thereof one new subsection (b), dealing with the same subject matter, effective upon the first billing after January 1, 2024, which shall read as follows (additions in **bold and underlined** and deletions in **bold and strikethrough**):

"SEC. 15-2102. CURBSIDE RECYCLING CARTS.

[...]

(b) **Fee for Curbside Recycling**. The fee for curbside recycling of curbside recyclable materials shall be three and 69/100 dollars (\$3.69) per single-family residence per month. Residential buildings of five (5) dwelling units or less shall be charged three and 69/100 dollars (\$3.69) per unit per month.

A residential refuse collection fee of ten and **08/100 79/100** dollars (\$**10.0810.79**) per month will be combined with the curbside recycling fee of three and 69/100 dollars (\$3.69) per month, and the combined fee will be added to the property's quarterly City utility bill. Said combined fee will be known as "solid waste collection and recycling fee" of **thirteenfourteen** and **77/10048/100** dollars (\$**13.7714.48**) per month, and its payment shall be applied immediately after storm water fees and prior to water or sewer charges.

<u>Section 3</u>. That Chapter 15, "GARBAGE AND TRASH," of the Moline Code of Ordinances, Section 15-2200, "FEE FOR RESIDENTIAL REFUSE COLLECTION," is hereby amended by repealing said section in its entirety and enacting in lieu thereof one new Section 15-2200, dealing with the same subject matter, effective upon the first billing after January 1, 2024, which shall read as follows (additions in <u>bold and underlined</u> and deletions in <u>bold and strikethrough</u>):

"SEC. 15-2200. FEE FOR RESIDENTIAL REFUSE COLLECTION.

The fee for residential refuse collection shall be ten and 08/100 dollars (\$10.08) ten and 79/100 dollars (\$10.79) per single-family residence per month. Residential buildings of five (5) dwelling units or less shall be charged ten and 08/100 dollars (\$10.08) ten and 79/100 dollars (\$10.79) per unit per month. Said fee will be added to the property's quarterly City utility bill and will be combined with the recycling fee for curbside recyclable materials of three and 69/100 dollars (\$3.69). Said combined fee will be known as "solid waste collection and recycling fee" of thirteen and 77/100 dollars (\$13.77) fourteen and 48/100 (\$14.48) per month, and its payment shall be applied immediately after stormwater fees and prior to water or sewer charges."

<u>Section 4.</u> All ordinances, resolutions, and parts thereof in conflict with this Ordinance are hereby repealed to the extent necessary to give effect to the provisions of this Ordinance.

<u>Section 5.</u> This Ordinance and every provision thereof shall be considered severable. If any word, phrase, clause, sentence, paragraph, provision, section, or part of this Ordinance is found to be void, unconstitutional, or otherwise unenforceable, all remaining portions of this Ordinance not so declared void, unconstitutional, or unenforceable shall remain in full force and effect.

<u>Section 6.</u> That this Ordinance shall be in full force and effect from and after passage, approval, and if required by law, publication in the manner provided for by law.
