

Council Bill/General Ordinance No. 3047-2023

AN ORDINANCE

AMENDING Chapter 20, "MOTOR VEHICLES AND TRAFFIC," of the Moline Code of Ordinances, Appendix 10 thereof, "PARKING PROHIBITED AT ANY TIME," by removing Fortieth Street, on the east side, from Fourth Avenue, north for a distance of 200 feet; adding Fortieth Street, on east side, from Second Avenue to Fourth Avenue; and adding Fortieth Street, on west side, from Fourth Avenue, north 208 feet to the property line between properties of 235 40th Street and 225 40th Street.

WHEREAS, current signage prohibits parking on both sides of Fortieth Street, and City staff received a request, from a business owner on this street, to allow parking; and

WHEREAS, the Director of Engineering reviewed the request and recommends **removing Fortieth Street, on the east side, from Fourth Avenue, north for a distance of 200 feet; adding Fortieth Street, on east side, from Second Avenue to Fourth Avenue; and adding Fortieth Street, on west side, from Fourth Avenue, north 208 feet to the property line between properties of 235 40th Street and 225 40th Street.**

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MOLINE, ILLINOIS, as follows:

Section 1 – That Chapter 20, "MOTOR VEHICLES AND TRAFFIC," of the Moline Code of Ordinances, Appendix 10 thereof, "PARKING PROHIBITED AT ANY TIME," is hereby amended by removing Fortieth Street, on the east side, from Fourth Avenue, north for a distance of 200 feet; adding Fortieth Street, on east side, from Second Avenue to Fourth Avenue; and adding Fortieth Street, on west side, from Fourth Avenue, north 208 feet to the property line between properties of 235 40th Street and 225 40th Street.

Section 2 – That pursuant to Section 1-1107 of the Moline Code of Ordinances, any person, firm or corporation violating any of the provisions of this ordinance shall be fined not more than seven hundred fifty dollars (\$750.00) for each offense.

Section 3 – That this ordinance shall be in full force and effect from and after passage, approval, and if required by law, publication in the manner provided for by law.



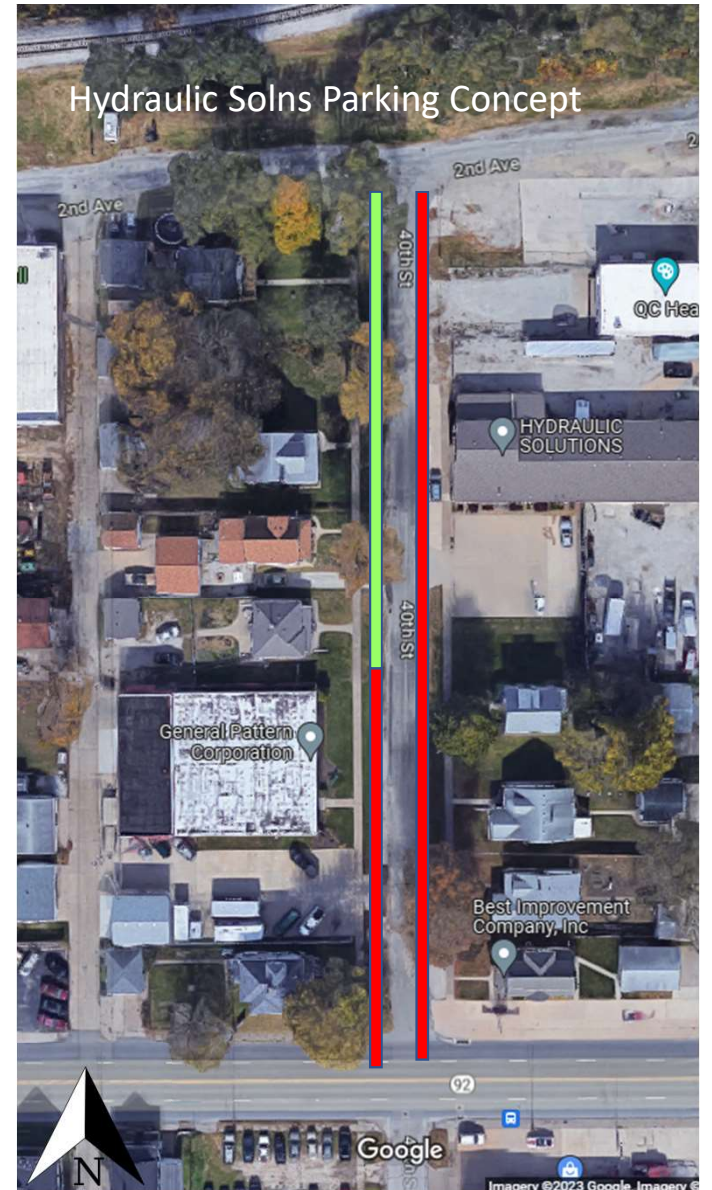
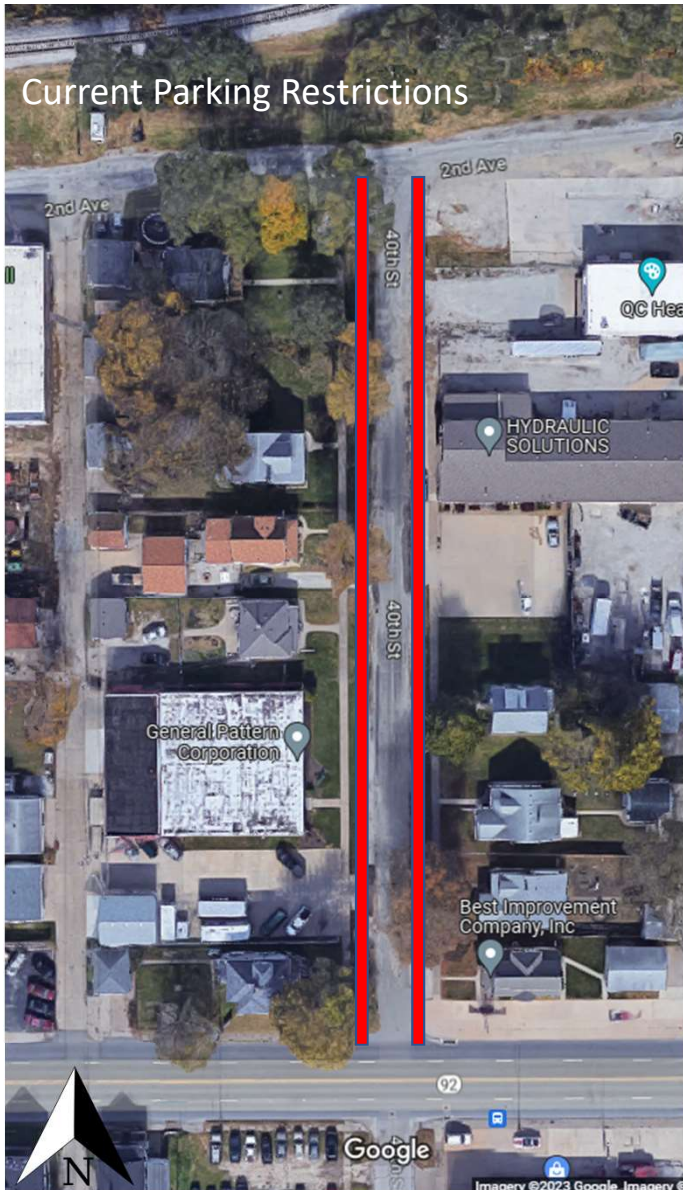
