

Council Bill/General Ordinance No. 3049-2023

AN ORDINANCE

LEVYING and assessing taxes for the City of Moline, Illinois, for the tax levy year 2023, collectible in the year 2024, and enacting an ordinance relating to the same subject matter.

WHEREAS, the City of Moline levies an annual tax on all real property located within the City to be collected the following year, and it is utilized as a revenue source for the City’s budget; and

WHEREAS, the City Council established an estimate of levy, pursuant to Section 18-60 of the Property Tax Code, not less than twenty (20) days before the effective date of this Ordinance; and

WHEREAS, all notices and procedures required to be completed as a precedent to the adoption of this Ordinance have been performed in the manner required by law; and

WHEREAS, this Ordinance sets forth the City’s tax levy for 2023, collectible in 2024.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MOLINE, ILLINOIS, in exercise of its home rule powers, as follows:

**Section 1** – That the total amount of appropriations for all corporate purposes legally made to be collected from the tax levy of the current fiscal year is hereby ascertained to be the sum of Sixteen Million, Three Hundred Forty-Six Thousand Six Hundred and Ninety-Six Dollars and no cents (\$16,346,696).

**Section 2** – That this Council hereby determines that the amount of money estimated to be necessary to be raised by taxation upon the taxable property within the City of Moline, Illinois, for general corporate and special municipal purposes is \$16,346,696, and the levy for general corporate fund purposes and levies for separate special fund purposes are set forth and designated as follows:

Debt Service Fund	\$5,621,204
Police Pension Fund	\$1,845,115
Fire Pension Fund	\$1,944,816
Park Fund	\$3,258,761
Library Fund	\$3,090,000
General Corporate	<u>\$ 586,800</u>
Total Tax Levy	\$16,346,696

**Section 3** – That the total amount of Sixteen Million, Three Hundred Forty-Six Thousand Six Hundred and Ninety-Six Dollars and no cents (\$16,346,696), ascertained above, be and is hereby levied and assessed on all property subject to taxation within the City of Moline, Illinois,

according to the value of said property as assessed and equalized for State and County purposes for the current fiscal year.

**Section 4** – That this levy Ordinance is adopted pursuant to the procedures set forth in the Illinois Municipal Code, 65 ILCS 5/8-3-1 et seq., and Chapter 2, Article 1, Sec. 2-1105 of the Moline Code of Ordinances; provided, however, that any tax rate limitation or substantive limitation as to tax levies in the Illinois Municipal Code in conflict with this Ordinance shall not be applicable to the Ordinance pursuant to Section 6 of Article VII of the Constitution of the State of Illinois.

**Section 5** – That the City’s Director of Finance is hereby directed to file with the Rock Island County Clerk, on or before the time required by law, a certified copy of this Ordinance duly certified by the Moline City Clerk.

**Section 6** – That this Ordinance shall be in full force and effect from and after passage, approval, and if required by law, publication in the manner provided for by law.


