AN ORDINANCE

AMENDING Chapter 20, "MOTOR VEHICLES AND TRAFFIC," of the Moline Code of Ordinances, by amending Appendix 31, "SNOW ROUTES."

WHEREAS, the City of Moline is a home rule unit of government and has the authority to adopt ordinances, to promulgate rules and regulations that pertain to its government and affairs and the authority to protect the public health, safety, and welfare of its residents; and

WHEREAS, in Chapter 20 of the Moline Code of Ordinances, the City has adopted ordinances and promulgated rules and regulations concerning motor vehicles and traffic; and

WHEREAS, in the exercise of its home rule powers, the City desires to amend its Code of Ordinances concerning parking on snow routes and the enforcement of the traffic code.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MOLINE, ILLINOIS, as follows:

Section 1 – That the facts and statements contained in the preambles to this Ordinance are found to be true and correct and are hereby adopted as part of this ordinance.

Section 2 – That Chapter 20, "MOTOR VEHICLES AND TRAFFIC," Appendix 31, is hereby amended as follows (with additions marked by underline and deletions marked by ~~strikethrough~~):

Fifth Avenue, on both sides, between First Street and Fourth Street.
Fifth Avenue, on both sides, between Eighth Street and Eleventh Street.
Seventh Avenue, on both sides, between Thirteenth Street and Sixteenth Street.
Seventh Street, on both sides, between Sixteenth Avenue and Eighteenth Avenue A.
Tenth Street, on both sides, between Fourth Avenue and Sixteenth Avenue.
Twelfth Avenue, on both sides, between Seventh Street and Nineteenth Street.
Twelfth Avenue, on both sides, between Thirtieth Street and Thirty-Sixth Street Court
Fifteenth Street, on both sides, between Third Avenue and Sixteenth Avenue.
Sixteenth Avenue, on both sides, between Seventh Street and Sixteenth Street.
Eighteenth Avenue, on both sides, between Seventh Street and Tenth Street.
Twenty-fifth Street, on both sides, between Sixth Avenue and Sixteenth Avenue.
Twenty-sixth Street, on both sides, between Fourth Avenue and Seventh Avenue.
Thirty-fourth Street, on both sides, between Sixteenth Avenue and Twenty-sixth Avenue.
Forty-first Street, on both sides, between Fourth Avenue and Fifth Avenue.
And adding the following new:

Fourth Avenue, on both sides, between First Street and Thirteenth Street.

- Fourth Avenue, on both sides, between Twenty-Fourth Street and Twenty-Fifth Street.
- Fifth Avenue, on both sides, between Eleventh Street and Nineteenth Street.
- Fifth Avenue, on both sides, between Twenty-First Street and Twenty-Seventh Street.
- Fifth Avenue, on both sides, between Thirty-Six Street and Fifty-Fifth Street.
- Sixth Avenue, on both sides, between Twelfth Street and Eighteenth Street.
- Eleventh Avenue B, on both sides, between Twenty-Fifth Street and Twenty-Seventh Street
- Fifteenth Street Place, on both sides, between Seventeenth Avenue and Eighteenth Avenue A.
- Twenty-Third Avenue, on both sides, between Fifteenth Street A and Twelfth Street.
- Twenty Sixth Avenue on both sides between 34th and 48th Street
- Twenty-Seventh Street, on both sides, between Eleventh Avenue B and Twenty-Third Avenue.
- Thirty-Ninth Street, on both sides, between Fourth Avenue and Sixth Avenue.
- Forty-First Street, on both sides, between Tenth Avenue and Eleventh Avenue.
- Twenty-Sixth Avenue, on both sides, between Thirty-Sixth Street and Forty-Eighth Street.
- Forty-Eighth Street, on both sides, between Fourth Avenue and Fifth Avenue.
- Forty-Eighth Street, on both sides, between Eleventh Avenue A and Fourteenth Avenue.
- Forty-Eighth Street, on both sides, between Twenty-Third Avenue and Twenty-Sixth Avenue.

Section 3 – That if any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision and such holding shall not affect the validity of the remaining portions hereof.

Section 4 – That all prior ordinances and resolutions in conflict or inconsistent herewith are hereby expressly repealed only to the extent of such conflict or inconsistency.

Section 5 – That this Ordinance shall be in full force and effect from and after passage, approval, and if required by law, publication in the manner provided for by law.
