AN ORDINANCE

AMENDING Chapter 20, "MOTOR VEHICLES AND TRAFFIC," of the Moline Code of Ordinances, by amending Appendix 33, regarding traffic regulations on private property.

WHEREAS, the City of Moline is a home rule unit of government pursuant to the Illinois Constitution; and

WHEREAS, the City is empowered to enter into agreements providing for the regulation of traffic and parking in the parking areas and/or private street of private property under its home rule powers and pursuant to Sections 11-209 and 11-209.1, of the Illinois Vehicle Code, 625 ILCS 5/11-209 and 1-209.1; and

WHEREAS, Chapter 20, Appendix 33, of the Moline Code of Ordinances identifies the private properties for which such agreements are in effect; and

WHEREAS, in the exercise of its home rule powers, the City desires to amend its Code of Ordinances to update the private properties for which such agreements are in effect.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MOLINE, ILLINOIS, as follows:

Section 1 – That the facts and statements contained in the preambles to this Ordinance are found to be true and correct and are hereby adopted as part of this Ordinance.

Section 2 – That Chapter 20, "MOTOR VEHICLES AND TRAFFIC," of the Moline Code of Ordinances, is hereby amended by deleting Appendix 33 in its entirety, and in lieu thereof, the following language shall be substituted:

“APPENDIX 33. REGULATIONS ON PRIVATE PROPERTY

As provided in this Traffic Code, contracts for enforcement of traffic regulations on private property are in effect at the following locations:

Premises and Address:

Crown Center, 4000 Avenue of the Cities.

Donut Delite Plaza, 3606 Avenue of the Cities.

King Plaza, 3624 and 3644 Avenue of the Cities.

Moline Housing Authority, 825 17th Street, 4141 11th Avenue A, and 1150 41st Street.

Moline School District, all school district properties.


Rock River Plaza, 3901 to 3941 41st Avenue Drive and 3900 to 3930 44th Avenue Drive.”

Section 3 – That if any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision and such holding shall not affect the validity of the remaining portions hereof.

Section 4 – That all prior ordinances and resolutions in conflict or inconsistent herewith are hereby expressly repealed only to the extent of such conflict or inconsistency.

Section 5 – That this Ordinance shall be in full force and effect from and after passage, approval, and if required by law, publication in the manner provided for by law.


